In continuation to earlier notifications, round 3 allotment procedure for MBBS and BDS courses will be carried out as per the schedule given below:

<p>Application form (Registration) Start date for filling of on-line application form and deposition of required application fee It is a mandatory step for subsequent process. Both the parts (Part 1 and Part 2) of the application form must be filled and completed. Candidates who could not complete both the parts (Part 1 and Part 2) of the application form earlier, may also complete the same.</p> <p>Those who are already registered earlier need not register again. Note: A candidate allotted/upgraded a seat in round 2 of counseling and has not joined the allotted seat and wishes to participate in round 3, must re-register / fill fresh application, deposit required application fee and deposit the security amount again, as applicable.</p> <p>Candidate who is not covered under the clauses from I to X of other eligibility criteria but falls under clause XI is also required to fill the application form / register.</p>	From 08.10.2024

Candidate who falls under clause XI "Other" of Other Eligibility Criteria (All India candidates) [to be considered for allotment against vacant seats available after exhausting State Merit list of candidates of clauses I to X] <p>Note: Candidate having Joined status (upto Round 2) and does not wish to upgrade and wishes to retain his/her seat need not to fill choices in Round 3.</p> <p>Candidates participating in round 3 must fill choices keeping in view the choices also for the virtual vacancies that may arise due to upgradation of a joined candidate of earlier round and vacancies available due to exhaustion of NRI / PwD / Category candidates.</p>	
<p>Defence/PM candidates Document verification – at Academic Block, SMS Medical College, Jaipur, for Defence/PM candidates as per the notification</p> <p>Candidates must present themselves physically for document verification as per the list to be made available at the website</p>	14.10.2023 (9.00 am)
<p>PwD candidates Verification of Disability certificate (issued by centers approved by MCC) of persons with disabilities (PwD) candidates of all categories at Academic Block, SMS Medical College, Jaipur, as per the notification</p> <p>All PwD candidates (not verified earlier) must present themselves physically for document verification as per the list to be made available at the website</p>	14.10.2023 (9.00 am)
<p>NRI candidates Document verification and seat allotment option – at Academic Block, SMS Medical College, Jaipur, for NRI candidates as per the notification and list to be made available at the website</p> <p>All NRI candidates willing to upgrade (Round 1 / Round 2 allotted) as well as those willing to participate in Round 3 NRI allotment (Round 1 / Round 2 registered but not allotted NRI seat and newly registered candidates) must present themselves physically for seat allotment option.</p> <p>Candidates holding a NRI seat, if not present physically on 14.10.2024 for exercising seat allotment option, shall be deemed having retained his/her NRI seat.</p> <p>All NRI candidates allotted a NRI seat in Round 1 / Round 2 and now willing to participate in Round 3 on Non-NRI seat leaving his/her NRI allotted seat must also present themselves physically.</p> <p>Candidates who participate in round 3 NRI allotment process and get / retain a NRI seat (of Round 1 / Round 2) are automatically excluded from general merit and shall not be allowed to participate in round 3 allotment process for Non-NRI seats.</p> <p>Candidates who get allotment on NRI seat shall submit the requisite bond at the time of allotment.</p>	14.10.2023 (9.00 am)

<p>Reporting, document submission (including prescribed eligibility criteria) at the allotted college desk at Academic Block, SMS Medical College, Jaipur along with printout of allotment letter, all original documents, required bonds etc. and 2 copies of application form along with photocopies of all relevant documents as listed in information booklet</p> <p>Round 1 / Round 2 joined candidates who get upgraded in Round 3 shall bring verified proof of transaction/fee receipt issued by Round 1 / Round 2 joined college, their original documents and fee will be transferred directly to Round 3 upgraded college within 24 hours of reporting. The difference of fee (as per allotted college) will be deposited by the candidate during round 3. If the round 1 / round 2 joined college fee is more than round 3 allotted college, the fee will be transferred by round 1 / round 2 college to round 3 college and round 3 allotted college will refund the excess amount by NEFT or RTGS, to the candidate.</p>	19.10.2024 to 23.10.2024 (9.00 am to 5.00 pm)

<p>Note: Round 1 / Round 2 joined candidate, who filled choices for upgradation but allotted same college, seat type & category in Round 3, need not report again for the same college. If round 3 allotted college is same but the allotted seat type or allotted category gets changed then the candidate will have to report again.</p> <p>At the time of joining, all the joined candidates of round 1, round 2 as well as round 3 will have to submit a bond / bank guarantee* (if applicable). 1. Refer information booklet, college information sheet and college fee structure etc. and other information at the website. Regarding fee, also refer order dated 19.05.2022 of Hon'ble Supreme Court in civil appeal no. 3978-3995/2017.
2. Document verification process for Round 3 candidates will be done at the time of reporting, for allotted candidates only. The candidates need not report for document verification at any verification center (selected during application form filling).
3. PwD, Defence/Para Military candidates (who were not verified earlier) must present themselves physically for certificate verification before the admission board on **14.10.2024** as per the notification to be made available at the website.
4. All PwD candidates who wish to participate are required to get their PwD Certificate issued from the MCC designated center (16 MCC designated centers). For this, visit the MCC website (mcc.nic.in) regularly.
5. A candidate allotted/upgraded a seat in round 2 of counseling and has not joined the allotted seat and wishes to participate in round 3, is required to fill application form again and must deposit required application fee and deposit the security amount again, as applicable.
6. All fresh candidates are required to deposit non-refundable application fee of INR 2500/- (INR 1500/- for SC, ST, ST-STA category candidate of Rajasthan state domicile) + applicable transaction charges.
7. A candidate allotted a seat (fresh / upgraded) in round 3 of counseling and does not join the allotted seat, his/her security amount will be forfeited. Such candidate shall not be eligible to participate in further round.
8. Candidates having joined status after round 3 will not be allowed to participate in further round.
9. Candidate who joins the course on allotment of round-3 counselling or retains his or her seat (allotted in earlier round) in round-3, shall not be allowed to resign the course (including returning of original documents) on or before the last date of admissions as scheduled by MCC/NMC/DCI and conditions of bond shall be applicable.
10. The candidates are advised to visit the website www.rajugneet2024.org regularly for all relevant information.

Important: For candidates willing to participate/upgrade in Round 3, it is mandatory to fill fresh choices in Round 3 (irrespective of whether the candidate was allotted/joined a seat in Round 1 / Round 2 or not).

The choices filled by a candidate in Round 1 / Round 2 shall be scraped and will not be considered for Round 3. If a candidate does not fill fresh choices for Round 3 then he/she will not be considered for allotment / upgradation in Round 3.
